Motion Bryngelson, second Annette to approve June Minutes, Bills and Committed Monies as presented. Motion carried. (5-0)

**Fire:**

Motion Annette second Molacek to approve land use permit at 607 Main Ave, a solar array structure, contingent on approval of Otter Tail Power. Motion carried. (5-0)

Motion Blattenbauer, second Molacek to approve \$1,200 for gravel on 280<sup>th</sup> St that we share with Richwood Township. Motion carried. (5-0)

Motion Annette, second Molacek to approve Liberty Park concrete walk way – cost \$11,300 and playground structure – cost \$57,556, and submit request for grant from WE Health \$30,000. Payable from CIF. Motion carried. (5-0)
